


It has been a really humbling and heartening term for me. Project Development would not be as enriching or fulfilling if not for my team, whose commitment and passion has inspired me tremendously as well.

For instance, both of us led a team of students to stage a re-enactment depicting the potential problems facing a construction worker and a foreign domestic worker at the 3rd Annual Asia Pro Bono Conference 2014. During your term, you will be involved in organising NUS Law's second Migrant Workers' Awareness Week, which would consist of a week-long string of activities, possibly including panel discussions, games, quizzes and movie screenings. How substantial your role will be also depends on your personal choice. You will have a lot of opportunities to ideate and come up with new initiatives to tackle and increase awareness on issues that migrant workers face.

Both of us have found serving as Students for Migrants Directors to be immensely rewarding. Moot Parliament Programme David Crawshaw

The Moot Parliament Programme (MPP) is organised by the Ministry of Education (MOE) to promote legal awareness and active citizenry among secondary school students through role-playing members of parliament, researching public policy, drafting legislation and engaging in mock parliamentary debates. NUS Pro Bono Group provides student-mentors who work with expert-mentors from private practice or Attorney-General's Chambers and MOE officials to guide the MPP participants. Our role is significant because we bridge the knowledge and generation gap between the students and the professionals. Being project director is extremely enjoyable and richly rewarding - not only is the enthusiasm and ingenuity of the student participants very impressive, but the friendliness and gratitude from MOE and the expert-mentors is deeply touching. Being a project head is not very taxing because MOE does most of the organising for key events; the key is communicating effectively with MOE officials (who are actually quite easy to work with) and NUS student-mentors (who are generally self-motivated and reliable mentors). There is a palpable sense of achievement on the part of all involved when everything comes together - when an event is successfully concluded, when the students use their creativity to tackle social ills, when the participants present their final bills, and when the debates are under way. I feel that NUS PBG (and the MPP project director's role in PBG) does important and meaningful work in helping MOE in the smooth running of MPP which is a laudable and valuable project for the students and the future of the nation.





Legal Clinics Loh Tian Kai & Wang Yu Fei

If you have a knack for administrative work, rostering volunteers while battling StartNowLaw and other stakeholders, this role is for you! The amount of administrative effort accompanying this role appears deceptively little, but with the new Mandatory Pro Bono and the ever-changing new implementations to sort out the teething problems (Think: StartNowLaw), this job demands a high level of adaptability, organisation and thick skin.

Legal Research Chan Jia Sheng

Being Project Head of "Legal Research" (previously known as LEAP (Research)), I can confidently say that the projects under this branch exposes you to a side of society that most of us will probably never see. Our collaboration with the full-time staff of Project X has shown us the darker side of Singapore's seemingly glitzy surface. Our members heard first hand from sex workers about the stigma they face both from the authorities and general public. I'm glad to say our research for Project X on travel bans and the "yellow card system" will be used by the staff for a position paper to relevant authorities, highlighting the plight of these sex workers. In addition, the brochure we are preparing will no doubt be a way for sex workers to understand the laws that govern them.

Another group of beneficiaries we work with are Secondary school students. Our work with Project Schools (in collaboration with The Law Society's Pro Bono Services Office), even though quieter this year, aims to educate youth on crimes commonly committed by youth. We help prepare lesson plans and guidebooks for students and teachers both to use in class. I am glad to say our work is being put to use in classrooms!

Even though legal research can be menial at times, it is no doubt important. The oft-quoted and clichéd phrase "knowledge is power" is oft-quoted and clichéd for a reason – it is true. Having knowledge of the law is having the power to make informed decisions. It is the power to know your rights and knowing how to stand up for them. Being a member of Legal Research has given me the chance to be part of this empowering process. I strongly encourage people who want to be part of this process to sign-up and make a difference!





LEAP Jethro Leong & Joey Ng

The Legal Education Awareness Programme (LEAP) aims to educate youth-at-risk on the legal consequences of unlawful behavior. Through the use of group discussions, skits and games, we help the youths to reflect critically, equipping them with knowledge to distinguish right from wrong in the eyes of the law. Topics include, but are not limited to, substance abuse, smoking, gang-related offences, petty crimes and sexual offences.

LEAP strives to provide youths with positive role models. In our interactions with the youth, we teach them about the standards of the law. In turn, the youth share with us about their lives, and we learn about their lives and the problems they face.

As the largest youth education project in the Pro Bono Group, LEAP is currently in partnership with 7 schools and social organizations, with the potential to reach many more. As a project director you will help to curate these relationships and manage LEAP's expansion to reach out to more beneficiaries. The journey has been long and uncertain, but the smiles and the friendships gained make it all worthwhile. If education and relationship-building is your calling, do consider running and/or future participation!

Syariah Court Friends

The newly-initiated Syariah Court Friends has allowed students a deeper exposure into Svariah law as well as court practices (which are seldom delved into in the core law curriculum). Student volunteers cater to an inflow of walk-in clients, who have questions ranging from divorce issues to issues of settling their will. Throughout the process, students will be rotated and are allowed to sit in for mediation processes and court rulings, thus having a holistic yet practical overview of the Syariah Court. We hope to expand the Svariah Court Friends Scheme in future, as students gain depth and breadth of knowledge about Syariah Court processes. One scheme we are looking forward to work on is to have students sit in during Court trials and afterwards, explain the judge's ruling to the parties after trial (as parties may not be as well-versed in court language and the law).

The role for the Syariah Court Friends Project Head would mainly be two-fold. Firstly, you will coordinate the programme by organising volunteer schedules as well as disseminating information to them. Secondly, you will be involved in cross-sector collaboration or talks that the Syariah Court has to expand the programme - for example, offering feedback to the Syariah Court and being called to sit in for meetings with other organisations that the Syariah Court works with.

Having seen the growth of the Syariah Court Friends project, it has been incredibly encouraging to see both Malay and non-Malay speaking volunteer participants actively involved in the project, and being exposed to different aspects of Syariah Law. We have been blessed to work with a good team at the Syariah Court which has, in their best capacity, done their utmost to contribute to students' learning by exposing volunteers to different aspects of the organisation.
