## pro bono awareness week

We welcome all our new members into PBG this year. May your experience as a PBG member be meaningful and fulfilling!



2017 marks the fifth year since the Community Justice Centre (CJC) was formed. In anticipation of this significant milestone, CJC organised a fundraising concert featuring performances by various members of the legal community. Given CJC's long-term partnership with PBG for the University Court Friends (UCF) initiative, several PBG members volunteered to help out for this concert and show our support to an important community partner.

On 29 Oct 2016, CJC organised a fundraising concert as a prelude to its fifth anniversary, while relying on crowdfunding to raise funds for its operations.

The CJC Fundraising Concert is part of a string of projects and initiatives known as Voices from the Courts. Voices from the Courts is a collaboration between the artist Jack Tan and the CJC. Jack Tan had focused on how voice works in court – timbre, tone, echo, cacophony, lyricism, dissonance, etc. – and in particular the experiences of litigants-in person. These

were translated into graphic scores, which were then interpreted and sung by the Anglo-Chinese Junior College Alumni choir to create a sound and art installation called Hearings. This work then formed a springboard for a major fundraising initiative where funds for and awareness of CJC's vital work can be raised through music and visual art.

The CJC Fundraising Concert was held at The Arts House, a museum which used to be our Old Parliament House. Concert attendees got to sit at the very seats our country's founding leaders sat at during parliament sessions, and enjoy a wide range of music performed by Singapore's legal community. There were performances by judges, lawyers, volunteers and staff representing different parts of the court community. Hearings was also displayed at the concert venue for that day, and the ACJC Alumni Choir as well as Jack Tan himself both performed an item each during the concert.

Ultimately, Voices from the Courts highlights the way that art and law can come together to create new art and to support meaningful legal programmes that help the underprivileged.

To show our support to CJC during this joyous occasion, our PBG EXCO and UCF volunteers helped out for this event. We assisted in ushering guests, registering them for the event and collecting donations. Some of us were even fortunate enough to help out backstage while the concert was going on, allowing us to get up close and personal with some of the performers that day.

The CJC Fundraising Concert is PBG's first ad-hoc collaboration with CJC. While this event did not provide a typical pro bono experience, it was certainly very humbling seeing so many members of the legal fraternity come together for a good cause. We hope that this event has strengthened PBG's partnership with CJC, and will pave way for more exciting and meaningful collaborations in the future!

From 5th to 9th December 2016, several Year 1 and Year 2 members from Project Law Help (PLH) participated in the newly introduced PLH Attachment Programme, which enables members to go on attachment with Voluntary Welfare Organisations (VWOs) and other community organisations. The objective of these attachments is to help us better understand the operations of these organisations and the legal issues that they face in the course of their work, so that we can better target our research focus and ensure that our work is relevant and useful to our intended beneficiaries.

In AY2016-17, we are fortunate to have All Saints Home (www.allsaintshome.org.sg) come on board as a Project Partner, and in December 2016, five PLH members participated in the abovementioned weeklong attachment with All Saints Home. Our members had the opportunity to visit all four of the Home's centres and interviewed a range of staff members and social workers from various departments, as part of an itinerary specially developed by All Saints Home for the PLH Attachment Programme.

The attachment has been a highly eye-opening experience for our members and helped us to gain much insight into the eldercare sector in Singapore, as well as better understand some of the legal concerns that personnel in the social service sector face. We also had some very enjoyable and insightful conversations with the staff at the various centres!

PLH is very thankful to All Saints Home for helping to specially plan a comprehensive itinerary for us that

Our project directors introduce two of PBG's longest-standing projects, Syariah Court Friends (SCF) and legal clinics.

Project Directors of Legal Clinics

Throughout the year, PBG Legal Clinics has recruited volunteers for our various partners on a regular basis. However, as part of our efforts to expand the project and reach more beneficiaries, Legal Clinics has taken on five new clinics including the Potong Pasir CC, Jurong Spring CC and Woodlands CC clinics, as well as the JusEquity and NTUC LawWorks Clinics. Taking on these new clinics means that there are more opportunities for volunteers and more slots for students to take on – this expansion also means that we reach more beneficiaries by facilitating clinics in more areas.

As part of our expansion efforts, Legal Clinics is also exploring the clinic manager scheme which allows student volunteers to take charge of a clinic on a more regular basis, instead of volunteering ad hoc. The clinic manager scheme also allows volunteers to take on greater responsibility for each clinic, including collecting the case lists and setting up the clinic. As of now, this scheme is still in its infancy, but we are hoping to involve more students in due time.
